Bids shall be opened in the presence of Bidders' representatives who choose to attend **2074/12/21, 14:00PM** at the office of **Procurement unit, Kathmandu Metropolitan City office, JDA Complex, Bagdurbar, Kathmandu**. Bids must be valid for a period of **120** counting from the day of bid opening and must be accompanied by bid security, amounting to **Nrs.35,00,000(Thirty-five Lakh)**, which shall be **valid for minimum 30 days** beyond the bid validity period ( **i.e. 150 days after bid opening**).
